## JOINING FEE AND CONTRIBUTIONS

A minimum fee between **R 300 for Children and Students** and **R500 for Adults** is required to sign up for a Stokvel with SGTT and to ensure that the Stokvel account remains open. The contributions by each member will be dependent on the Stokvels constitution. It remains the responsibility of the members of the Stokvel Club to ensure that all information provided is correct. The opening of a Stokvel account with SGTT is subject to application form being completed and approved. Interest rates are not applicable. Exclusive club discounts will apply.

## NON-PAYMENT, CANCELLATIONS AND WITHDRAWALS

Non-payment by a member remains the responsibility of the Stokvel Club. The centralized SGTT Stokvel team will contact the designated parties of the Stokvel Club regarding non-payment by members.

A minimum fee of R500 is required to keep the Stokvel account open. The account will be closed should the minimum required amount of R500 not be available. We reserve the right to close the account without notice. Should all nominated signatories wish to close the Stokvel account, written notice must be provided to the SGTT Stokvel Team.

Any reimbursement of money will be reconciled against statements. Any reimbursed funds will be refunded to members / individual of the Stokvel Club as outlined in the constitution for the Stokvel Club with a minimum of 2 signatories. In the case of cancelation of membership and withdrawal an administration fee of R 300 per person will be charged. Waiting period for pay out of funds is subjected to a 30 day waiting period.

## STATEMENTS

We will communicate a statement each month to all members of the Stokvel Club.

## BOOKING

SGTT will not proceed with any booking until we have received instruction from the Stokvel Club's chairperson and/or nominated signatories who act on behalf of the Stokvel Club. Once the Stokvel Club wishes to finalize their travel, they will be referred to a SGTT travel consultant to begin the booking process, or can email [Bookings@socioolitetravel-tours.co.za](mailto:Bookings@socioolitetravel-tours.co.za) and all funds will be transferred to your booking.

## AUTOMATIC OPT IN

All members who sign up as members of the Stokvel Club will automatically opt in to monthly marketing and statement update, through electronic direct mailers to the email addresses provided at the time of sign-up.

## MEETINGS

Meetings remain the responsibility of the Stokvel Club and as outlined by the Stokvel Club's Constitution. SGTT will attend meetings as determined by the Stokvel Club. 2 weeks' notice period is required for STTG to attend a meeting. Attendance will not be guarantee and can be subject to postponement.

## REFERRAL

For any referrals provided, SGTT will contribute 3% of the stokvel's total contributions will apply. Each club will be limited to 5 referrals.
